





- Min 3 years since establishment
- Demonstrate proven novel business/ technology, evidence of funding or yo-y growth



Individuals

- Min 5 years of residency
- Tangible contribution to Abu Dhabi economy

APPLICATION PROCESS





Registration & Profile Setup

During registration, applicants create their company profile. The platform automatically identifies the appropriate target audience based on the information provided by the applicant.



Application Completion

Applicants complete a structured set of application questions designed to capture their performance and achievements across all impact areas.

80% Quantitative Assessment



Evidence Submission

Applicants upload all required evidence to validate their responses. Each submission must be supported by formal and verifiable documentation.



Evaluation & Scoring

All submissions are evaluated by independent evaluators and judges using the SKEA Impact Model to ensure a fair evaluation within the applicant's designated target audience category.



Impact Interview

Shortlisted applicants proceed to a qualitative interview, where they clarify their submitted data, present examples of their impact, and demonstrate the measurable outcomes achieved.

Results & Award Ceremony

Final results are announced at the SKEA Award Ceremony, where outstanding companies and individuals are formally recognized and celebrated.

SCORING BLUEPRINT



101 Scoring is Based on Your Target Audience

 \rightarrow

While the scoring system remains consistent across all target audiences, final comparisons are made only within the same target audience to ensure fairness, given the expected differences in scale and scope of the audience types

What this means for you:

- All applicants are assessed using the same scoring methodology and criteria
- Comparisons and ranking are only made within your own target audience (e.g., SMEs, startups, corporates, individuals)
- Scores are normalized to reflect performance relative to peer applicants within the same audience type
- Strong performance within your audience type increases your likelihood of being shortlisted

02 Thresholds are Set for Each Question

Every question in the application has a dedicated scoring threshold to maintain consistency, fairness, and minimum performance standards. These thresholds ensure that all responses meet the expected level of detail, evidence, and relevance, regardless of applicant type.

How thresholds work:

- Each question has a minimum score requirement that must be met to remain competitive
- Thresholds ensure responses demonstrate detailed, evidence-based, and measurable impact
- Lower-quality responses fall below the threshold and receive reduced scores
- Thresholds are adapted across audience types to ensure equitable assessment despite differences in scale or resources

@3 Assessment Focuses on Your Strongest Impact Area

 \rightarrow

While applicants provide information across multiple impact areas, the scoring system identifies and emphasizes the area in which you demonstrate the strongest, most tangible impact. This rewards depth of achievement and recognizes applicants who excel in a specific impact area.

What this means:

- The scoring model highlights the impact area where you demonstrate the strongest performance
- This ensures you are evaluated in a way that reflects your most meaningful and proven impact
- Strong performance in one area can outweigh broader but less significant performance across multiple areas
- Applicants with deep excellence in a single impact area are not disadvantaged compared to those with broad but moderate achievements
